MEMORANDUM OF UNDERSTANDING between SOUTH KITSAP SCHOOL DISTRICT NO. 402 and SERVICE EMPLOYEES INTERNATIONAL UNION LOCAL 925 (SEIU)

Whereas, the District and Union agree to the following compensation of a select group of SEIU Classified Staff for work performed during the dates of Monday, June 21, 2021 through Friday, August 20, 2021.

The District has a need to fulfill work assignments over the duration of the 2021 summer that will require the support of several SEIU bus driver and food service staff members. Interest in the position(s) will be gathered and assignments will be awarded at the individual department level.

After the challenging 2020-2021 school year and the work that SEIU staff have completed, compensation for 2021 summer work was established to incentivize the forfeiting of a summer break.

Therefore, the District and Union agree to compensate hired bus drivers who are assigned a driving route and food services staff at one and one-half (1 ½) times the employee's regular wage rate for all hours worked in their assigned capacity during the dates of Monday, June 21, 2021 through Friday, August 20, 2021.

This agreement is not precedent setting for any future summer work opportunities.

This memorandum of understanding will take effect upon the date of execution and sunset on August 31, 2021.
