

Early Entrance to Kindergarten (EEK)

Early entrance is for children who are able to demonstrate that they have the necessary kindergarten foundation skills and who are functioning at or above the 5 ½ year age level in all areas including the ability to participate in group instruction. Tests are given by teacher(s) one on one and last about an hour. The child is tested on fine and motor skills, demonstration of oral language and vocabulary, concepts of book and print, components of early kindergarten essential learnings, and school behaviors. **Testing fee: \$100, non-refundable**.

Applying for Early Entrance to Kindergarten (EEK)

Complete the <u>Application</u> to apply for Early Entrance to Kindergarten. The Google Form will contain Steps 1,2, and 3 listed below. Applications for EEK open April 1st.

Step 1. Watch this <u>video</u> (embedded in Section 1 of the Google Form Application). The informational video on early kindergarten testing will cover questions about early entrance to kindergarten, statistics of success, along with questions and answers with a certificated kindergarten teacher for what to expect through the process of testing, trial period, and whether EEK is right for your family.

Step 2. Review the Frequently Asked Questions (FAQ) and Information (this document) for the process of testing for early entrance to kindergarten.

Step 3. Complete the application if you would like to apply for Early Entrance to Kindergarten.

Steps after application has been received by SKSD:

Step 4. Schedule a parent interview. (April-June).

Step 5. Pay testing fee and schedule testing appointment. After the interview, if you wish to continue to the testing phase, contact Tracy Schneewind at schneewi@skschools.org or 360-874-7058 for instructions. Testing is scheduled for May-June

Testing Day: The parent and child will meet the teacher in the outside breezeway of Mullenix Ridge Elementary School (please arrive on site about 10 minutes before your scheduled appointment time). The parent will remain onsite, in the foyer, outside of the building, or in their car while the teacher(s) conduct the tests with the child.

- Testing will take approximately one hour. Arrive 10 minutes before your appointment time.
- Keep your scheduled appointment; call to reschedule 24 hours before if child is sick.
- If you bring younger children with you, please bring things to occupy them for the full time.
- Parent(s) are not allowed in the testing rooms. Parent(s) will need to stay on site.

Step 6. Testing results will be sent via email around 10 business days after testing. After the assessment, the assessment committee will meet and review the testing data. Information on placement will be e-mailed to the parents within ten business days of the assessment. No make-up tests will be given.

Step 7. If child is approved to register for Kindergarten, please connect with the elementary school.



Early Entrance to Kindergarten FAQ – Frequently Asked Questions

What is the birthday cutoff for eligibility for Early Entrance to Kindergarten testing?

Children must turn five between **September 1 and November 1** to participate in the early entrance evaluation.

What assessment areas are evaluated for Early Entrance to Kindergarten?

- **Cognitive**—a standardized developmental inventory is used to assess the child's cognitive development, which includes: ability to attend to visual and auditory stimuli and to retrieve information; critical thinking skills; and ability to conceptualize, discriminate, and draw relationships among object features (such as size and shape).
- **Fine Motor**—a standardized developmental inventory is used to assess the child's fine muscle control and coordination, particularly the small muscles in the arms and hands that allow performance of increasingly complicated tasks such as tracing and cutting.
- **Communication**—a standardized developmental inventory is used to assess the child's receptive language (ability to discriminate, recognize, and understand sounds and words, and understanding and use of conversational skills) and expressive language development (use of words to relate information to others, knowledge of and ability to use simple rules of grammar, and use of language as a tool for social contact).
- Perceptual Motor— a standardized developmental inventory is used to measure child's ability to integrate fine motor and perceptual skills for tasks such as stacking blocks, copying geometric shapes, letters, and numbers.
- **Social/Emotional**—a child's readiness is assessed by information provided on the Parent Questionnaire and by behavior observed during the assessment session.

How well do children need to score on the assessments to qualify for early entrance?

Early entrance is for children who are able to demonstrate that they have the necessary kindergarten foundation skills and who are functioning at or above the 5 1/2 year age level in all areas including the ability to participate in group instruction. Students must also demonstrate age-appropriate (5-year-old range) social/emotional development.

When will I know the testing dates?

Families will receive a call to schedule their student's assessment session after a completed application packet and testing fee has been paid. Early entrance evaluations will be scheduled for May or June. Appointments are on a first come, first served basis. Testing will take place at Mullenix Ridge Elementary School located at 3900 Mullenix Road, Port Orchard, WA 98367.



Who does the testing?

The child is individually evaluated by certificated staff which includes a certificated teacher and a specialist.

How long does the assessment session(s) take?

The assessment session lasts approximately one hour. Parents will not be allowed in the testing rooms. Parents must remain on school property the entire time.

What happens if my child cannot complete the assessments?

Children must complete the entire early entrance to kindergarten evaluation on their assigned test date within their allotted assessment period. Incomplete assessments will not be scored. Children who are unable to complete the assessments will <u>not</u> be allowed to complete the evaluation at a later date.

Can my child take the assessment more than once?

Children are not allowed to take the early entrance to kindergarten assessments more than once.

When will I know the results of the testing?

Test results will be e-mailed to parents within 10 business days after the evaluation. If your child passes testing, the neighborhood school will also be notified, and you can register your child for kindergarten with the school.

How much does the screening and testing cost?

There is a \$100.00 non-refundable testing fee.

When will I be able to register my child into kindergarten?

You may **not** register your child until he/she has been found eligible through the assessment process. If your child qualifies, your neighborhood school will be notified of your eligibility to enroll. Connect with the elementary school within 2 weeks of the eligibility notification.

What is the trial period for Early Entrance Kindergarteners?

All early entrance to kindergarten children will be on a trial period during the first four weeks (30 calendar days) of school, at which point the school principal will make the final enrollment determination.

What if my child doesn't qualify for early entrance to kindergarten?

Entrance criteria are applied equitably to all applicants. Appeals for matters related to problems clearly identified with the testing conditions will be considered. Appeals must be in writing and received by the District Office, attention Lisa Fundane't, fundanet@skschools.org within 14 days of the date of the letter notifying parents of results. The findings of the appeals review committee are final and will be sent to the parents/guardians within 30 days.
